

Backgrounder

On 13 September 1999, the United Nations General Assembly adopted, by consensus and without reservation, its landmark, pioneering and norm-setting resolution 53/243 on the **Declaration and Programme of Action on a Culture of Peace**. Among other things, it provided the driving force for the implementation of the UN-declared **International Decade for Culture of Peace and Non-Violence for the Children of the World (2001-2010).** Asserting and re-affirming the commitment of the totality of the Member States for building the culture of peace, the UNGA has adopted every year since 1997 resolutions on the subject.

Ever since the initiative taken in 1997 to include a separate agenda item on the culture of peace and the UNGA decision to do so allocating the item to the plenary of the General Assembly, every year the Assembly has adopted by consensus a comprehensive, self-standing resolution on the culture of peace. The General Assembly, through its annual substantive resolutions, has highlighted the priority it attaches to the full and effective implementation of these visionary decisions which are universally applicable and is sought after by the vast majority of all peoples in every nation.

Recognizing the need for continual support to the further strengthening of the global movement to promote the Culture of Peace, as envisaged by the United Nations, particularly in the current global context, the day-long, General Assembly High Level Forum is intended to coincide with the anniversary date of the adoption of 53/243. Substantively, the Forum is to be an open public opportunity for the UN Member States, UN system entities, civil society including NGOs, media, private sector, and all others interested, to have an exchange of ideas and suggestions on the ways to build and promote the Culture of Peace and to highlight emerging trends that impact on the implementation process.

When we see what is happening around us, we realise the urgent need for promoting the culture of peace - peace through dialogue - peace through non-violence. The culture of peace begins with each one of us — unless we are ready to integrate peace and non-violence as part of our daily existence, we cannot expect our communities, our nations, our planet to be peaceful. We should be prepared and confident in resolving the challenges of our lives in a non-aggressive manner. This individual dimension is the core message of the culture of peace, more so in recent years, and can create the collective action for peace which the United Nations is aiming to achieve for more than the seven decades of its existence.

The Forum is convened by the UNGA President and he/she takes the lead in the preparations of the event which focuses on the implementation of the Programme of Action. It is organized through broad partnership and inclusive collaboration among Member States, international organizations and civil society. Following the wide-ranging success of the UN General Assembly's High Level Forum on The Culture of Peace held on 14 September 2012, the Assembly adopted by consensus the resolution 68/125 on "Follow-up to the Declaration and Programme of Action on a Culture of Peace", co-sponsored by 105 Member States led by Bangladesh.

In its operative para13, it said "Requests the President of the General Assembly to consider convening a high level forum, as appropriate and within existing resources, devoted to the implementation of the Programme of Action on the occasion of the anniversary of its adoption, on or around 13 September."

Earlier in 2012 a resolution (A/Res/67/106) which, inter alia, also requested the President to consider convening the High Level Forum, was adopted by the Assembly at its 67th session with the co-sponsorship of 84 Member States also under Bangladesh's leadership.

In 2016, UNGA resolution A/Res/71/252 reiterated its request to the President to consider convening the High Level Forum. It was adopted at the Assembly's 71st session with the cosponsorship of 102 Member States under Bangladesh's leadership.

In her travels it became evident that to create the changes necessary and persuade governments to listen to the voices of their children, legislative changes must be implemented to protect children. She is also advocating that where children are under threat of death and destruction, safe areas must be created, areas off limits to any form of military attack. This is her life's work.

At the invitation of UN Secretary-General U Thant, in 1970, Sri Chinmoy began leading meditations for delegates and staff and other programmes for peace at UN Headquarters, and the Singers are honoured to continue in this spirit.

"A culture of peace is a set of values, attitudes, traditions and modes of behaviour and ways of life based onrespect for life, ending of violence and promotion and practice of non-violence through education, dialogue and cooperation"



"Education at all levels is one of the principal means to build a culture of peace. In this context, human rights education is of particular importance."



"Governments have an essential role in promoting and strengthening a culture of peace."

"Civil society needs to be fully engaged in fuller development of a culture of peace."



"The educative and informative role of the media contributes to the promotion of a culture of peace."

"A key role in the promotion of a culture of peace belongs to parents, teachers, politicians, journalists, religious bodies and groups, intellectuals, those engaged in scientific, philosophical and creative and artistic activities, health and humanitarian workers, social workers, managers at various levels as well as to nongovernmental organizations."



"Progress in the fuller development of a culture of peace comes about through values, attitudes, modes of behaviour and ways of life conducive to the promotion of peace among individuals, groups and nations."

"The United Nations should continue to play a critical role in the promotion and strengthening of culture of peace worldwide."
